Explanation of Responses:

- The shares acquired represent the number of shares that automatically vested pursuant to a grant of Restricted Share Units on May 5, 2011. The original grant of 16,660 shares vests over a four year period: 25% on May 5, 2012 and 6.25% per quarter thereafter.
- Each restricted share unit represents Vistaprint's commitment to issue one ordinary share.
- These restricted share units vest over a four year period: 25% of the original number of shares vest one year after the date of grant and 6.25% vest per quarter thereafter.
