## **Explanation of Responses**

- 1. The shares acquired represent the number of shares that automatically vested pursuant to a grant of Restricted Share Units on May 7, 2009. The original grant of 8,762 shares vests over a four year period: 25% on May 7, 2010 and 6.25% per quarter thereafter.
- 2. The shares acquired represent the number of shares that automatically vested pursuant to a grant of Restricted Share Units on May 7, 2009. The original grant of 8,761 shares vests over a four year period: 25% on May 7, 2010 and 6.25% per quarter thereafter.
- 3. Includes 723,375 shares held by RHS Holdings Incorporated, of which The Eastern Irrevocable Trust and The Western Irrevocable Trust are the sole shareholders.
- 4. Mr. Keane and/or his spouse are beneficiaries of The Eastern Irrevocable Trust.
- 5. Mr. Keane and/or his spouse are beneficiaries of The Western Irrevocable Trust.
- 6. Immediately following this transaction, the reporting person transferred this grant 50% to The Eastern Irrevocable Trust and 50% to the Western Irrevocable Trust. The reporting person's pecuniary interest in the

grants was unchanged.

- 8. This restricted share unit vests over a four year period: 25% of the original number of shares vest on May 6, 2011 and 6.25% vest per quarter thereafter.
