Explanation of Responses:

- The shares acquired automatically vested pursuant to an award of restricted share units (RSUs), with each RSU representing Cimpres's commitment to issue one ordinary share.
- The shares acquired automatically vested pursuant to an award of performance share units (PSUs), with each PSU representing Cimpres's commitment to issue one ordinary share following the determination of the number of shares issuable pursuant to the award based on the level of achievement against the performance conditions.
- These RSUs vest over the following four-year period: 25% of the original number of RSUs granted vest on the Date Exercisable in Table II and 25% of such number of RSUs vest yearly thereafter.
- These PSUs vest over the following four-year period: 25% of the number of shares determined to be issuable pursuant to the award based on the level of achievement against the performance conditions vest on the Date Exercisable shown in Table II and 6.25% of such number of shares vest quarterly thereafter.
