The RSU's were granted under the 2005 Non-Employee Director's Share Option Plan, as amended, pursuant to which each non-employee director of the Company authomatically receives RSU's having a fair value (determined by the closing price as listed on the NASDAQ Global market on the grant date) of \$110,000 at each year's annual board meeting at which he or she serves as director.
